The Raritan Valley YMCA is a nonprofit organization. A YMCA membership is open to all youth, adults, and families regardless of their personal circumstances. We require that all program participants have a current YMCA membership. Memberships are valid for 12 months from date of issue and are non-refundable. There is a \$10.00 charge for guests per day.

A membership card will be issued to all Wellness Center Members. This card must be presented each time you use the facility. A replacement fee of **\$2.00** will be charged for all membership cards that are lost.

Only personal trainers employed by the Raritan Valley YMCA are permitted to train members on the premises.
